OFFICIAL RULES**

THIS IS A CLOSED PROMOTION ONLY OPEN TO RESIDENTS OF ANY ONE (1) OF THE UNITED STATES (INCLUDING D.C.) WHO ARE AT LEAST 18 AND THE AGE OF MAJORITY AND STUDENTS ENROLLED IN GOOD STANDING AT AN ACCREDITED COLLEGE OR UNIVERSITY IN THE TERRITORY WHO OBTAIN THE PUZZLE DIRECTLY FROM SPONSOR.

OVERVIEW AND TIMING: Data Open: Hologram Edition Giveaway ("**Sweepstakes**") begins at 12:00:00 a.m. Eastern Time ("ET") on 12:00:00 a.m ET pm August 26, 2019 and at 11:59:59 p.m. ET on December 31, 2020 ("**Sweepstakes Period**").

During the Sweepstakes Period, eligible individuals (see below for eligibility requirements) (each a "**Participant**") may enter the Sweepstakes by completing an online entry form for this Sweepstakes and submitting a correct guess to the Puzzle (defined below) at <http://Citadel.com/win> ("**Sweepstakes Site**"). Following the conclusion of the Sweepstakes Period, Sponsor (defined below) will randomly select three (3) potential winners from among all eligible entries received during the Sweepstakes Period (each a "**Potential Winner**"). There is only one pool of entries in this Sweepstakes from among all students who participate from the eligible school(s). Participation in this Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor.

ELIGIBILITY: This Sweepstakes is only open to residents of any one (1) of the United States including the District of Columbia ("**Territory**") who are at least eighteen (18) years old and the age of majority in their jurisdiction of residence, and are students currently enrolled and in good standing at an accredited college or university in the Territory who obtain the Puzzle directly from Sponsor. Employees, officers, directors, members, managers, representatives and agents of Sponsor and its advertising and promotion agencies, and any other entities participating in the design, promotion, marketing, administration or fulfillment of this Sweepstakes, as well as each of their parent companies, subsidiaries and affiliated companies (collectively, the "**Released Parties**"), and the immediate families (defined as any spouse, domestic partner, parent, legal guardian, grandparent, sibling, child or legal ward, or grandchild, regardless of where they reside) and members of the same household (whether legally related or not) of any such person are ineligible to participate or win a prize in this Sweepstakes. HOW TO ENTER: During the Sweepstakes Period, Participants who have access to a tablet computer and the internet may enter the Sweepstakes by obtaining one (1) hologram kit, while supplies last, that, once assembled, will play a video describing the puzzle (“**Puzzle**”) directly from Sponsor and, after solving the Puzzle, visiting the Sweepstakes Site and following the directions to complete the online entry form with the required information, including the eligible entrant’s answer to the Puzzle. Sponsor may distribute the Puzzle during certain of its campus recruiting activities. Normal Internet access and usage charges imposed by your Internet Service Provider may apply.

In order to receive an entry into the Sweepstakes, Participants must use their school email address on the entry form and Participant’s answer to the Puzzle must be correct, as determined in Sponsor’s sole discretion.

Proof of submitting an entry (such as an automated computer receipt confirming entry or “thanks for entering” screen or message) does not constitute proof of actual receipt of an entry. The Sweepstakes Site’s database clock will be the official timekeeper for entries in the Sweepstakes. DRAWING AND NOTIFICATION OF POTENTIAL WINNERS: Upon the conclusion of the Sweepstakes Period, three (3) potential winners will be selected in a random drawing by the Sponsor from among all eligible entries received. Each Potential Winner may be required to complete and sign, and return, without alteration and in the form presented by Sponsor, a declaration of eligibility and liability/publicity release (unless prohibited by law) and proof of student status at an eligible school

(“**Winner Documents**”), within the time frame specified by Sponsor or prize may be forfeited. ARV is as of date of printing of these Official Rules. The difference in value of prize as stated herein and value at time of prize notification, if any, will not be awarded. Each prize will be awarded only to the individual identified on the entry form of the winning entry.

TO THE EXTENT PERMITTED BY APPLICABLE LAW, THE PARTIES EACH AGREE TO FINALLY SETTLE ALL DISPUTES ONLY THROUGH ARBITRATION; PROVIDED, HOWEVER, THE SPONSOR SHALL BE ENTITLED TO SEEK INJUNCTIVE OR EQUITABLE RELIEF IN THE STATE AND FEDERAL COURTS LOCATED IN COOK COUNTY, ILLINOIS, AND ANY OTHER COURT WITH JURISDICTION OVER THE PARTIES. IN ARBITRATION, THERE IS NO JUDGE OR JURY AND REVIEW IS LIMITED. THE PARTIES AGREE THAT, EXCEPT AS SET FORTH ABOVE, ANY CLAIM, SUIT, ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THIS PROMOTION WILL BE RESOLVED SOLELY BY BINDING ARBITRATION BEFORE A SOLE ARBITRATOR UNDER THE STREAMLINED ARBITRATION RULES PROCEDURES OF JAMS INC. ("**JAMS**") OR ANY SUCCESSOR TO JAMS. IN THE EVENT JAMS IS UNWILLING OR UNABLE TO SET A HEARING DATE WITHIN FOURTEEN (14) DAYS OF THE FILING OF A "DEMAND FOR ARBITRATION," THEN EITHER PARTY CAN ELECT TO HAVE THE ARBITRATION ADMINISTERED BY ANOTHER MUTUALLY AGREEABLE ARBITRATION ADMINISTRATION SERVICE WHO WILL HEAR THE CASE. IF AN IN-PERSON HEARING IS REQUIRED, THEN IT WILL TAKE PLACE IN CHICAGO, IL OR IN THE PARTICIPANT'S HOMETOWN IF REQUIRED BY APPLICABLE JAMS RULES. THE FEDERAL

OR STATE LAW THAT APPLIES TO THESE OFFICIAL RULES WILL ALSO APPLY DURING THE ARBITRATION. DISPUTES WILL BE ARBITRATED ONLY ON AN INDIVIDUAL BASIS AND WILL NOT BE CONSOLIDATED WITH ANY OTHER PROCEEDINGS THAT INVOLVE ANY CLAIMS OR CONTROVERSY OF ANOTHER PARTY, INCLUDING ANY CLASS ACTIONS OR CLASS ARBITRATIONS; PROVIDED, HOWEVER, IF FOR ANY REASON ANY COURT OR ARBITRATOR HOLDS THAT THIS RESTRICTION IS UNCONSCIONABLE OR UNENFORCEABLE, THEN THE AGREEMENT TO ARBITRATE DOES NOT APPLY AND THE DISPUTE MUST BE BROUGHT IN A COURT OF COMPETENT JURISDICTION IN COOK COUNTY, ILLINOIS. SPONSOR AGREES TO PAY THE ADMINISTRATIVE AND ARBITRATOR'S FEES IN ORDER TO CONDUCT THE ARBITRATION (BUT SPECIFICALLY EXCLUDING ANY TRAVEL OR OTHER COSTS OF ENTRANT TO ATTEND THE ARBITRATION HEARING). EITHER PARTY MAY, NOTWITHSTANDING THIS PROVISION, BRING QUALIFYING CLAIMS IN SMALL CLAIMS COURT.
